

## **Article 1**

### **What is Orbitur Camping Club**

ORBITUR CAMPING CLUB represents a loyalty programme of Orbitur resulting in benefits granted to active Members.

## **Article 2**

### **Requirements to join Orbitur Camping Club**

1. All individuals with a minimum of 16 years of age may join the programme, as long as they meet the necessary formalities and conditions.
2. In principle, any corporate entity, company or association may submit individual proposals for Members of the ORBITUR CAMPING CLUB.
3. To join the ORBITUR CAMPING CLUB programme, the provision of the requested personal information is a mandatory requirement (in particular the name and contact details, the email address being a mandatory data).
4. Orbitur reserves the right of admission, namely for reasons of poor behavioural history in relation to Orbitur or any other persons or entities.

## **Article 3**

### **Duties of the Members**

ORBITUR CAMPING CLUB members shall have the following duties:

- a) To respect and promote respect for the Internal Rules and Regulations of the establishments of the Orbitur Group;
- b) To settle debts incurred in the establishments within the regulated time limit;
- c) To inform/update his/her data, particularly in the case of change of residence or alteration of identity data or personal contact;
- d) Do not transmit to a third party, for any purpose, his/her position as a Member.

## **Article 4**

### **Rights of the Members of Orbitur Camping Club**

To active Members the following advantages are granted:

- a) Discounts all year round on the price lists to the public in force at any given time in Orbitur establishments;
- b) Access to exclusive offers and products at any period of time;
- c) Possibility of making advance reservations without payment of a guarantee deposit if required;
- d) The use at special prices of the sports facilities and other reserved leisure areas that exist in Orbitur establishments;
- e) Multiple discounts or special advantages in the establishments of partners adherent to the ORBITUR CAMPING CLUB project;
- f) Information and news, namely via newsletter;
- g) Support service for ORBITUR CAMPING CLUB Members in the establishments' front desks, during the respective periods of operation, and also by telephone at +351 226061360 or e-mail at orbiturporto@orbitur.pt (working days: 9.30 a.m. –12.00 noon, and 3 p.m.– 6 p.m.).

## **Article 5**

### **Extension of Rights and Duties**

The rights referred to in the previous articles may cover the direct family members, when in the presence of the respective active Member. Direct family members must be understood to mean spouses and first-degree relatives (parents, in-laws and children or stepchildren of the OCC Member).

## **Article 6**

### **Registration and Renovation Process**

- a) All those interested in joining the club should fill in the request/proposal for registration/renewal, designated for the purpose at the receptions' front desks or online on Orbitur's website ([www.orbitur.pt](http://www.orbitur.pt));

- b) The registration or renewal for ORBITUR CAMPING CLUB membership is subject to the payment of registration/renewal costs which are annually defined by Orbitur;
- c) The registration or renewal are valid for a period of one calendar year (from 1 January to 31 December);
- d) Registrations or renewals made within the last quarter of the calendar year, for the same year, will have a 20% discount;
- e) The sequential renewal (without interruption) may have a discount of 20% in relation to the defined value for registration;
- f) The registration of a second OCC Member of the same household (spouses or first-degree relatives) has a 20% discount in relation to the value set for registration;
- g) For OCC registration/renewal individuals under 35 years of age or over 55 years of age benefit from a discount of 50% in relation to the amount annually defined for registration;
- h) OCC registrations/renewals proposed by collective entities for a number equal to or greater than ten (10) individuals, have a 50% discount in relation to the annually defined value for registration;
- i) The eventual non-acceptance of a proposal for accession to OCC obliges Orbitur to return 100% of the amount previously received.
- j) In view of the benefit of any of the advantages indicated in the preceding paragraphs, a proof fulfilling this condition is required.

#### **Article 7**

##### **Acceptance of the Regulation**

By registering as a Member of the ORBITUR CAMPING CLUB, the Member declares accepting all the conditions of this regulation.

#### **Article 8**

##### **Privacy and Personal Data Protection**

Orbitur - Intercâmbio de Turismo SA is the entity responsible for treating the provided personal data and has the techniques and organizational measures ensuring compliance with the General Regulation on the General Data Protection Regulation (GDPR). In accordance with the GDPR, OCC Members have the right of access, modification, personal data exclusion, treatment limitation, objection to data treatment and portability, in all applicable circumstances. #### **Article 9**

##### **Exclusion**

Orbitur may exclude from the club or suspend privileges to Members or their families, should they not comply with the obligations set forth in this regulation, or for conduct that is considered as damaging for the interest of Orbitur. The definition of the exclusion/suspension period, as well as a possible re-examination of readmission, shall be incumbent upon Orbitur.

#### **Article 10**

##### **Change of Regulation**

Orbitur reserves the right to amend this regulation without prior consent of the Members.

#### **Article 11**

##### **Omitted cases**

In cases not covered by this regulation, Orbitur shall decide.
